At the time of bid submittal, Tullis, Inc. listed Austin Enterprises of Bakersfield CA, Contractor License Number 764893, DIR Number 1000001896, to perform Bid Item 4 for 100% portion subcontracted. The bid item for Austin Enterprises should have been listed as Bid Item 12 for 100% portion subcontracted. Bid Item 4 is Traffic Control and Bid Item 12 is Crack Treatment. Austin Enterprises, subcontractor, is performing Crack Treatment Bid Item 12 not Traffic Control Bid Item 4. The Bid Item, for Austin Enterprises, was accidentally entered as the unit of measure, which is 4 LNMI, for Bid Item 12 Crack Treatment. Attached, please find a copy of Austin Enterprises' proposal received before bid time.
