Per the State of California – Department of Transportation, Subcontract List, the bid clearly reads:

- 1) Enter Bid Item Number (Item)
- 2) Enter percent of Bid Item subcontracted.
- 3) If the percentage of the bid item work is less than 100 percent, list the description of the portion of the work to be subcontracted. Enter the description of the percentage of work to be performed by subcontractor.

Item 4 Traffic Control System Lump Sum

GBA listed Fryman Management Inc. for 10% for partial traffic control
GBA listed Hi-Way Safety Rental Inc. for 25% with NO description given

With both subs listed for Traffic Control and is less than 100 % (both equaling 35%) thus making GBA nonresponsive, and by doing so makes the next responsive bidder Jabre Contracting Inc. as the low responsive bidder and awarded the contract.

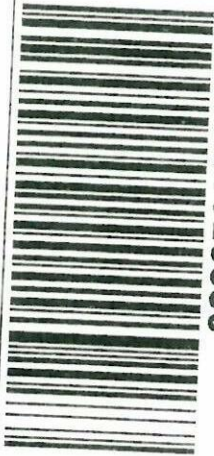
